



MEMORANDUM OF UNDERSTANDING  
between

OSTİM TECHNICAL UNIVERSITY  
Ankara, TURKEY



and

AUTONOMOUS UNIVERSITY OF SAN SEBASTIAN  
San Lorenzo, PARAGUAY

**Ostim Technical University** and Autonomous University of San Sebastian agree to implement this memorandum of understanding, believing that the process of university education can be enriched and international understanding strengthened, and wishing to establish relations between the institutions, hereby agree to cooperate with each other in areas of common interest as follows:

1. Participating institutions shall endeavor to promote collaboration through a broad range of activities such as:
  - a) Exchange of students;
  - b) Exchange of faculty (scholars);
  - c) Recognition of approved courses and credits;
  - d) Exchange of academic information and materials;
  - e) Organization of academic study programs;
  - f) Organization of joint research programs;
  - g) Organization of joint conferences, workshops and symposia
  - h) Cooperation between the Center for Industrial Policy and Development of the Ostim Technical University and the Autonomous University of San Sebastian in the fields including but not limited to joint research and organization of conferences and workshops
2. The terms of cooperation for each specific activity implemented under this Memorandum of Understanding shall be mutually discussed and agreed upon by both parties in a separate agreement, after pre-approval of both the **Senate of Ostim Technical University**, and the **Autonomous University of San Sebastian** prior to the initiation of that activity. Any such implementation agreements will form appendices to this Memorandum of Understanding.
3. Las consideraciones financieras y/o de financiación serán objeto de debate y acuerdo específicos en el marco de un acuerdo de ejecución independiente. Cualquier acuerdo de implementación de este tipo formará apéndices de este Memorando de Entendimiento.

4. The Memorandum of Understanding shall remain in force for a period of five years following the approval of the Higher Education Council of Turkey and from the date of the last signature. The Memorandum of Understanding may be amended or extended by mutual written consent of the two parties after the approval of both the Senate of **Ostim Technical University** and the **Autonomous University of San Sebastian**. The Memorandum of Understanding may be terminated by the appropriate authorities of either party giving three months' notice to the other party in writing; unless an earlier termination date is mutually agreed upon.
5. The Memorandum of Understanding as outlined in this document is not intended to be a legally binding document. Rather, it is meant to describe the nature and cooperative intentions of those institutions involved guidelines for cooperation. Nothing, therefore, shall diminish the full autonomy of either institution nor may any constraints to be imposed by either upon the other.
6. Confidentiality:

Both parties are obligated to keep confidential the information received from the other party -if the other party requires- The confidentiality obligation will be effective beyond the termination of this MoU.
